




System Refinements

Update Monthly Status ASC Collection Report – Display Toggle

There has been a small enhancement to the 'Update Monthly Status ASC Collection' report. Users can now toggle the data sort order between 'Oldest First' and 'Newest First' — available in both the Chart and Report views to ensure consistency across the whole report.





Capacity Tracker Data – CQC Refresh

A CQC refresh will place on Thursday 27th November 2025. Providers expecting changes to be applied by the CQC (assessment ratings, services or regulated activity) should review their account following the update. If any anomalies are found, such as incorrect or missing new/transferred locations, please reach out directly to CQC for assistance.





Key Initiatives for Providers

CareFind Image Upload Guidance Standards

Providers who have opted in and completed a public profile on CareFind should note that the image guidance has been refreshed. These updates are designed to:

- Ensure images are consistent and high-quality across profiles
- Support accessibility standards for users accessing the site with assistive technologies

The refreshed guidance applies to the 'Image' section of the CareFind Profile Page for both Home Care and Care Homes.

DHSC Consultation: Fair Pay Agreements in Adult Social Care

DHSC have launched a public consultation on how Fair Pay Agreements (FPAs) should work in the adult social care sector in England and is inviting providers to participate in a survey.

FPAs will allow workers and employers to jointly agree on pay and working conditions. This aims to improve recruitment, retention, and the quality of care.
